

Easter Stamper Promotion 2024

TERMS AND CONDITIONS

All entries and redemption are subject to the following terms and conditions – please read the following carefully.

Overview

Between the 15th March 2024 to 1st April 2024, members of Coral Island Casino may obtain a Easter Stamper Card from Cash Desk. On the first visit during the promotional dates each customer can receive a stamper card along with 1 stamp. Further stamps will be added on further visits. 1 stamp per gaming day per customer only. Stamps are only available from the Cash Desk. Rewards will be given based on the number of stamps received during the promotional period (as detailed below).

Rewards

1. On the 2nd visit (2 stamps), the customer will be rewarded with small egg pack.
2. On the 4th visit (4 stamps), the customer will be rewarded £10 match plays
3. On the 6th visit (6 stamps), the customer will be rewarded with Large Easter Egg.
4. On the 8th visit (8 stamps), the customer will be rewarded 2 x £20 match plays

Terms and Conditions of Entry

5. This promotion is open to all UK residents aged 18 years or over except employees of Coral Island, their families, agents or agencies and anyone else professionally connected to this promotion who are all precluded from participation.
